Past due accounts will be charged a service fee of 1.5% monthly (18% annual rate) or the maximum non-usurious rate at the time the account is past due, whichever is smaller, on all past due balances. Debtor accepts credit with the understanding that bills will be paid in accordance with our terms, regardless of where, when or how the materials purchased may be used. In the event collection is made through an attorney, reasonable attorney's fees and all other cost of collection shall be paid by the debtor. All accounts are subject to the credit limits set by our credit department. All payments will be applied first to any unpaid service charges and balance as Driven Power may determine. It is agreed that I/we shall notify Driven Power in writing by certified mail of any change in the ownership or form of ownership within five days of such change.
